







- Proxy Testing
- Disclosure of test content
- Sharing of answer strings
- Unauthorized testing aids





Questionmark Checklist



Corporate

- Aimed at companies who have employees taking

- Where integrity is important
- A useful guide for where to prioritize efforts

Deter

 Actions to deter employees from considering test fraud

Detect and Respond

 Actions to identify if test fraud is happening and respond if it does happen

Prevent

 Actions to prevent or make it harder for employees to cheat at tests and exams



Deter: recommended actions to prevent employees considering test fraud

Write a policy, requiring employees to take tests with integrity

Train on the policy

Bring managers onside - tone and culture are set at the top

Publicize security measures

Remove the need to cheat – provide learning opportunities



Prevent: recommended actions to make it harder for employees to cheat at tests

Limit access to questions/tests to those who need to know

Train authors and item writers in security

Use an assessment management system rather than an LMS

Ensure good audit trail and resistance to tampering

Vary/scramble tests between test takers

Update tests reasonably often

Consider a lockdown browser

Test above recall (so people can't "google" the answers)

Use reliable/secure technology (e.g. ISO 27001, SOC 2)

Review risks and make a security plan



Detect & Respond: actions to detect and respond to test fraud

Encourage anonymous reports of test fraud

Search for shared answers within company and external systems

Check LMS is not bypassed or exploited with wrong test results

Use organizational Single Sign On for test login

Monitor/proctor tests where possible/appropriate

Fair and robust process to deal with test integrity violations

- Communicate rules and consequences
- Message expectations
- Company Policy
- Professional Conduct
- Tone at the top
- Value of the exam

Exam design

- Multiple forms
- Scrambled questions
- Randomized order
- Back up content
- Retest rules
- NDAs
- Training
- Oversight







Deeper dive: Testing environment

Physical and digital environment conducive to fair testing

- Access
- Lockdown browser
- Only authorized materials
- Observe with scan



COVID lockdown case

- School rules varied
- No advance notice
- No consent or waiver
- No alternative available
- Scan visible to all students
- School did have legitimate interest
- Unreasonable in that instance



Room scan

- Consistent rules
- Consistent application
- Notify test taker early
- Obtain consent
- Test in secure place







Deeper dive: Test delivery

Ensuring test-taker identity

- Test taker identification
- Observation tools
- Reporting



Important security layers

- Data forensics
- Web monitoring
- Hotlines
- Incident response planning


